**FURTHER DELAY IN DESPATCH OF CIRCULAR  
IN RELATION TO A MAJOR TRANSACTION  
FOR THE FORMATION OF THE AMOLED JV COMPANY**

Reference is made to (i) the announcement of Truly International Holdings Limited (the “**Company**”) dated 14 July 2017 in relation to the major transaction regarding formation of the AMOLED joint venture company (the “**Announcement**”); and (ii) the announcement of the Company dated 28 July 2017 in relation to the delay in despatch of the Circular (the “**Delay Announcement**”).
